**The Symposium on Health Informatics in Latin America and the Caribbean (SHILAC 2015)** bridges medicine and computing to showcase health informatics research in Latin America and the Caribbean. ### **Submission Guidelines**

Papers to be presented at the Symposium (maximum 8-pages) will be submitted for a double-blind review by the Program Committee. The work must be original, and not published previously (abstracts, lectures, thesis permitted). Authors must be registered for the Full Conference Registration fee. Authors must commit to present their paper.

### **Extended Abstracts (Posters)**

Extended Abstracts submitted for the poster sessions (maximum 2-pages) will be submitted to double-blind review by the Program Committee. The Abstracts will be published in the proceedings. Authors must be registered for the Full Conference Registration fee. Authors must commit to present their poster.

### **Publications**

The proceedings of the works presented will be published in the Journal of Health Sciences of Puerto Rico (<http://prhsj.rcm.upr.edu/>). The journal is online and open access. It is published by the University of Puerto Rico Medical Sciences Campus and is indexed in PubMed, Index Medicus, MEDLINE, SCOPUS, Index Pharmacus, Science Citation Index Expanded (SciSearch®) and Journal Citation Reports/Science Edition. While papers may be submitted in English, Spanish or Portuguese, the journal will only publish papers in English, but contain an abstract in the three languages.

All authors are expected to present their work within the Symposium schedule.
